WHEREAS the Legislative Assembly of this Province stands prorogued to Thursday, the fifth of September inst., I have thought fit further to prorogue the said Legislative Assembly, and the same is hereby prorogued accordingly to Thursday, the seventeenth day of October next.

Given under my hand and seal at Fredericton, the fourth day of September, in the year of our Lord one thousand nine hundred and eighteen, and in the ninth year of His Majesty's Reign.
