To manufacture, buy, sell and deal in any way necessary to the undertaking of the Company, any timber, logs, lumber, wood and wood products or anything composed of wood, in whole or in part.

To have, hold, own, construct, maintain and operate on the Company's own property or elsewhere, under permit or license telephone lines, and for such purposes, to crect and maintain poles, pole lines and other fixtures and establish, maintain and erect poles for the use of the same.

To generate, transmit, distribute and sell, electricity for lighting, heating, power or other purposes, and erect, con-struct, maintain and operate on the Company's own property or elsewhere, under permit or license, poles, pole lines and other fixtures for such purposes.

To issue and allot fully paid up shares of the capital stock of the Company, in payment or part payment of any pro-perty, real, personal, movable, immovable or mixed, and of any rights and concessions purchased or acquired by the Company.

To acquire by purchase, subscription or otherwise, and own, hold, sell, mortgage, hypothecate, piedge or otherwise dis-pose of, the capital stock or any bonds, debentures, deben-ture stock or other interest in the Company, having objects of them and to acquire, assume and undertake the whole or all together or in part similar to those of this Company or any any part of the business, property or liability of any present firm or Company, carrying on in whole or in part, any busi-

ness which this Compnay is authorized to carry on or assum-ed of property suitable or desirable for the purposes of this Company, with power to amalgamate with any such Company and that the holder or holders of any such shares of stock, to exercise all the rights of ownership, including the right to vote thereon.

To sell, mortgage, pledge, lease, let, hire or otherwise part with or dispose of, the real and personal property and fran-chises, assets, rights and credits of the Company or any of the same or the undertakings of the Company or any of its operations, upon such terms and for such considerations as the Directors may determine.
