THE Honourable the Attorney General reports for the information of the Committee of the Executive Council:

That under and by virtue of Section 4 of the Workmen's Compensation Act. 1918, the "Workmen's Compensation Board" have reported to the Lieutenant-Governor-in-Council that, in their opinion, the following industries, not within the scope of Part 1 of the Act, might properly be brought within the scope of Part 1 of the Act, might properly be brought within the scope of Part 1 of the Act, wiz. Teaming, Shipbuilding, Printing, Laundries, Wholesale and Retail Stores, Fishing, Canning, Plumbing, Road Making, Transportation, Handling of Hides, Coal and Wood Merchants, Hospitals, Hotels, Window Cleaning and any industry to which, in the opinion of the Board, there is attached a hazard.

The Honourable Attorney General now recommends that an Order-in-Council be passed providing that the following industries be declared to be within the scope of Part'i of the

Act, viz., Teaming, Shipbuilding, Printing, Laundries, Whole-sale and Retail Stores (except as provided in sub-section (a) of Section 3 of the Act), Fishing, Canning, Plumbing, Road-Making, Transportation, Handling of Hides, Coal and Wood Merchants, Hospitals, Hotels and Window, Cleaning.

And the Committee of Council concurring in the said re-

port and recommendation, it is Accordingly So Ordered.
