PROCLAMATION

WHEREAS the Legislative Assembly of this Province stands prorogued to Thursday, the fifth of September inst., I have thought fit further to prorogue the said Legislative Assembly, and the same is hereby prorogued accordingly to Thursday, the seventeenth day of October next.

Given under my hand and seal at Fredericton, the fourth day of September, in the year of our Lord one thousand nine hundred and eighteen, and in the ninth year of His Majesty's Reign.

PROCLAMATION

WHEREAS Albion R. Foster, Esquire, High Sheriff of the County of Carleton, has made a return to the Provincial Secretary Treasurer setting forth that an election of the ratepayers of the Town of Hartland in the County of Carleton was held on the 28th day of September, A. D., 1918, to determine whether the inhabitants thereof should be incorporated under the provisions of Chapter 166 of the Consoildated Statutes, 1903, intituled "The Towns Incorporation Act"; that at said election there were one hundred and two (102) votes cast in favour of incorporation and fifty-two (52) votes cast against incorporation; that the boundaries of the said Town are as follows,-"Beginning where the western prolongation of the southern line of Lot Number 49 in the Parish of Brighton in Said County granted by the Crown to Robert Hallett strikes the centre or middle line of the River Saint John, thence southerly along said centre line of said river and following the western channel thereof. between the lower Becaguimic Island, or Matheson's Island, so called, and the western bank or shore of said river to a point where the western prolongation of the north side of the road leading from the main highway road on the eastern side of the said river below Flemming's mill, co called, to Ashland and Highgate strikes said centre line of said river, thence easterly along said westerly prolongation and the north side of said road to the rear of base line of the granted lands fronting on the eastern side of said River Saint John, thence northerly along said rear or base line to said southern line of said Lot Number 49, and thence westerly along the same and the western prolongation thereof to the place of beginning."

And it appearing by said return that the majority of the rate-payers within the said bounds had voted in favour of incorporation, I do therefore proclaim that the said Town comprised within said bounds hereinbefore described, be incorporated under and by virtue of the Towns Incorporation

Act, under the name of the "Town of Hartland."

HIS HONOUR the Lieutenant-Governor has been pleased to approve of the following Rules and Regulations:

That in addition to the Rules and Regulations passed by Order-in-Council governing the collection of the Amusement Tax, the following regulation be passed:

"No entertainment of whatever sort or description to which an admission fee is charged, and the proceeds of which are not wholly for patriotic, church or charitable purposes, shall be held without a permit allowing the said entertainment to be held, and providing at the same time for a supply of amusement tax tickets zecessary in connection therewith. If such entertainment is held without a permit from the Amusement Tax Inspector, the promoters of the same shall be liable to the penalties provided for in the 11th section of the Theatres and Cinematographs Act."
