That in addition to the Rules and Regulations passed by Order-in-Council governing the collection of the Amusement Tax, the following regulation be passed:

"No entertainment of whatever sort or description to which an admission fee is charged and the proceeds of which are not whelly for patriotic purposes, shall be held without a permit allowing the said entertainment to be held, and providing at the same time for a supply of amusement tax tickets necessary in connection therewith. If such entertainment is held without a permit from the Amusement Tax Inspector, the promoters of the same shall be liable to the penalties provided for in the 11th section of the Theatres and Cinematographs_Act."

REGULATIONS RE TAX, THEATRES AND CINEMATO. GRAPHS.

THE following regulations for the collection of a tax on persons attending places of amusement be adopted pursuant to 3 George V., Chapter 15, and amendments passed in 1918; (Passed Order-in-Council, May 8th, 1918.)

Every theatre owner shall provide a supply of amuse-1. ment tax tickets sufficient to accommodate his patrons.

2. Tickets of the denomination of one and two cents must always be kept on hand, and when a performance costing more than fifty cents admission is announced, the theatreowner shall make application to the Proincial Secretary-Treasurer for tax tickets of the denomination required by his proposed admission price.

3. Every theatre owner shall see that provision is made for the deposit of the amusement tax ticket in a receptacle which will be provided for that purpose.

4. Every theatre owner shall, not later than the tenth d from the sale

Failure to make out such return and remit the proceeds received from the sale of amusement tax tickets will be sufficient reason for the Provincial Secretary-Treasurer to refuse a further supply of a usement tax tickets.

5. The Provincial Secretary-Treasurer shall supply every licensed theatre owner with a reasonable supply of amusement tax tickets of such denominations as are required, and shall charge the same to the theatre owner. He shall also supply the theatre owner with a ticket chopper of such pattern as is approved, the cost of which shall be charged to the theatre owner and the costs of said tickets and chopper shall be a charge against a commission of ten per cent, which shall be
