allowed every theatre owner upon the gross amount of the sales of amusement tax tickets.

6. The Provincial Secretary-Treasurer shall, at the close of each fiscal year, after receipt of the returns from theatre owners for the month of October of that year, make up the amount of said commissions, and after deducting cost of tickets and receptacle supplied, shall remit the balance due the

7. The admission receipts, tickets, receptacle, forms, supplies and anything appertaining to the proper collection of this amusement tax shall be subject at any and all times to the inspection of a proper officer appointed for that purpose.

8. The amusement tax inspector shall report any violation of the Act and shall prosecute offenders of its provisions. He shall, at any time, have free admission to the theatre or any part thereof for the purpose of his work of inspection.

9. For the purposes of performances at race tracks, skating rinks, exhibitions and any amusements of like character, the owner or owners thereof shall give sufficient a sice to the Provincial Secretary-Treasurer, who shall make tuch arrangement for providing a receptacle and the collection of the amusement tax as he shall deem necessary.
