

13. Head North Branch Cains River south side Transcontinental Ry. The western 3 miles in width from west to east of that part of Block F south of the Transcontinental Railway. .... 16
14. About 11 miles east of McGivney Junction. The eastern part of Block F adjoining easterly the western 3 miles of said block measured from west to east not extending north of the Transcontinental Railway also that portion of Block 8 west of said Railway. .... 4
15. Extending from 2 to 6 miles east of McGivney Junction on The Transcontinental Railway. Those portions of Blocks B and H adjoining southerly the Transcontinental Railway and lying east of Portage Road. .... 5
