BY HIS HONOUR WILLIAM PUGSLEY. D. C. L., LL. D., K. C., P. C., LIEUTENANT GOVERNOR OF THE PROVINCE OF NEW BRUNSWICK.

WILLIAM PUGSLEY

WHEREAS, the Legislative Assembly of this Province convened on Thursday, the sixth day of March last, and tentinued its sittings until this day, being the seventeenth day of April instant, I have thought fit to prorogue the said Legislative Assembly, and the same is hereby prorogued actordingly, to Thursday, the twenty-ninth day of May next.

Given under my hand and scal at Fredericton, the seventeenth day of April, in the year of our Lord one thousand nine hundred and nineteen, and in the ninth year of His Majesty's reign.

HIS HONOUR the Lieutenant-Governor has been pleased to make the following order:

That under and by virtue of Section 4 of the Workmen's Compensation Act, 1918, the "Workmen's Compensation Board" have reported to the Leutenant Governor-in-Council that, in their opinion, the following industries not within the scope of Part One of the Act might properly be brought within the scope of Part One of the Act, viz.: Persons employed in the woods in logging, cutting or timber, pulp-wood, fire-wood, railroad ties or sleepers, or river driving, rafting, booming or the transportation of logs, timber, pulp-wood, fire-wood, railroad ties or sleepers.

The Honourable the Premier now recommends that an Order-in-Council be passed providing that the following industries be declared to be within the scope of Part One of the Act on and after the first day of August, A. D. 1919, viz. l'ersons employed in the woods, in logging, cutting of timber, pulp-wood, fire-wood, railroad ties or sleepers, or river drivirg, rafting, booming or the transportation of logs, timber, pulp-wood, fire-wood, railroad ties or sleep ROBERT MURRAY.
