LEGISLATIVE ASSEMBLY OF N. B.

RULES AND PRACTICE OF THE LEGISLATIVE ASSEM-BLY OF NEW BRUNSWICK.

Private and Local Bills. Bill or Local Bill introduced into this House shall be filed wit the Clerk of the House within ten days after the opening the Session, and in case of failure to comply with this provision the fee on the introduction of any such Private Bill she be double the fee provided for in Rule 84, applicable to such Bill, and Local Bills introduced after ten days of the opening of the Session shall pay the same fee as a Private Bill.

78.
