WHEREAS, it hath pleased Almighty God in his great goodness to vouchsafe this year unto our Dominion of Canada, a bountiful harvest and other blessings.

We therefore, considering that these blessings enjoyed by our people throughout said Dominion do call for a solemn and public acknowledgment, have thought fit, by and with the advice of Our Privy Council for Canada, to appoint, and We do appoint Monday, the thirteenth day of October next, as a day vest and other blessings with which Canada has been favoured this year, and We do invite all our loving subjects throughout Canada to observe the said day as a day of General Thanksgiv- of the Peace.

Of all which our loving subjects and all others whom these presents may concern, are hereby required to take notice and to govern themselves accordingly.

In Testimony Whereof, We have caused these Our Letters to be made Patent, and the Great Seal of Canada to be hereunto affixed. Keighley, Knight of Our Most Noble Order of the Garter, one of our Most Honourable Privy Council, Knight Grand Cross of Our Most Distinguished Order of Saint Michael and Saint George, Knight Grand Cross of Our Royal Victorian Order, Governor General and Commander-in-Chief of Our Dominion of Canda.
