## SUPPLEMENTARY LETTERS PATENT

### THE GRAND MANAN STEAMBOAT COMPANY, LIMITED

PUBLIC NOTICE is hereby given, that under the New Brunswick Companies' Act, 1916, and amending Acts, Supplementary Letters Patent have been issued under the seal of the Provincial Secretary-Treasurer, bearing date the Eighteenth day of October, 1919, whereby the capital stock of The Grand Manan Steamboat Company, Limited, has been increased from twenty thousand dollars divided into eight hundred shares of twenty-five dollars each, to sixty thousand dollars divided into six hundred shares of one hundred dollars each, and the powers of the Company extended as follows:

To construct, purchase, lease or otherwise acquire, charter, own, maintain, operate and manage, steamships, tugs, vessels, schooners and boats of every description; structures, erections, buildings, shops, works, appliances, machinery, plant and equipment of every nature and kind whatsoever, on land or on water, deemed by the Company to be deemed necessary or required for or in connection with the construction, manufacture, maintenance, operation, navigation, management or repair of vessels, works, undertakings, appliances or equipment therewith, and

for the accommodation and conveyance of passengers and freight, the loading, handling, forwarding and warehousing of the same.

Lands, water lots, docks, wharves, slips, shipyards, and ship works, terminal and other facilities of every description for the building, repair, management, equipment and employment of vessels, ships and boats.

To carry on any business incidental to the full and complete use and enjoyment of the works and facilities herein authorized or which may seem to the Company capable of being conveniently carried on in connection therewith, or calculated directly or indirectly to enhance the value of and render profitable any of the Company's properties or rights.

To acquire and undertake the whole or any part of the business, property and liabilities of any person or company carrying on any business which this Company is authorized to carry on, or possessed of property suitable for the purposes of the Company.

To use any of the funds of the Company to purchase or otherwise acquire and take and hold shares, bonds or other securities of or in any other company or corporation, and to promote any company having objects altogether or in part similar to those of this Company, or carrying on any business capable of being carried on so as to benefit this Company, and while holding the same to exercise all the rights and powers of ownership thereof, including the voting powers thereof.

To amalgamate with any other company having objects in whole or in part similar to those of this Company.

To dispose of any of the assets or undertakings of the Company by sale, lease or otherwise, taking in payment therefor stock, debentures or other securities of any corporation, or cash, or part thereof one way and part the other.

To act as general merchants and brokers for the purchase, sale and shipping of goods and chattels, wares and merchandise, and to carry on the business of buying, selling, gathering, curing and generally dealing in fish, and to maintain and operate plants for the curing and packing of fish, also cold storage plants for the preservation of fish of every nature and kind, and to do all and every act incidental to the carrying on of a general fish business, including the catching, packing, curing, shipping and selling of the same.
