1. Section 2 of the Act 9 George V., Chapter 3, The Jurors Act, 1919, is amended by striking out the word "Six" in the fifth line and inserting in place thereof "three" and reads as follows:

"2. Every male inhabitant between the age of twentyone years and sixty-five years being a British subject, and assessed in the county where he resides on real or personal estate or both together, of the value of Three Hundred Dollars, or on income to the amount of Three Hundred Dollars, shall be qualified to serve as a grand or petit juror in said county. The want of such qualification shall be a good cause of challenge or he may be excused on his own oath, C. S. 1903, c. 126, s.l. am"

2. Section 12 of said Act is also amended by adding thereto as sub-section (3) the following:

"3. At the time of the drawing of the grand and petit jury in this section mentioned said board shall also draw an additional number of persons not exceeding six as grand, nor ten as petit jurors, to serve as substitutes hereinafter mentioned and in case the Sheriff shall at the time of summoning any jury be convinced that he will be unable to procure the attendance of any grand or petit juror because of death, illness, legal disability or inability to be served with summons in consequence of absence from the county, the said Sheriff may, in the order in which they are drawn substitute an additional juror jurors to complete his panel."

CAR. IX.

An Act to Amend the County Courts Act.

(Passed 24th. April, 1920.)

Be it enacted by the Lieutenant-Governor and Legislative Assembly, as follows:

1. Section 22 of Chapter 116 of The Consolidated Statutes, 1903, relating to terms of Courts as amended by the Act 2 George V., Chapter 17 in so far as the same applies to Carleton County Court is hereby repealed and the following substituted in lieu thereof:

For Carleton County Court on the second Tuesday in January, the first Tuesday in May and the third Tuesday in September.

2. Section 22 of Chapter 116 of the Consolidated Statutes 1903. respecting the terms of Court insofar as the same applies to Kent County is repealed and the following substituted in lieu thereof:

For Kent County on the third Tuesday in January the first Tuesday in May, the second Tuesday in July and the fourth Tuesday in October.

3. Section 92 of said Chapter is amended by inserting in the third line thereof between "Statutes" and "subject" the words "with fifty per cent, added to the items on all fees to the attorney.'

4. Section 93 of the said Chapter is repealed and the following substituted in lieu thereof:

93. On the trial of a cause and on every argument before the Court or before the Judge at Chambers, the Judge may allow a counsel fee of not less than Five Dollars nor more than Twenty-five Dollars, in his discretion, provided, however, that the costs to be taxed to the Attorney in actions of debt, covenant, or assumpsit, when the debt or damages exceed Two Hundred Dollars, and in actions of Tort, when the damages exceed One Hundred Dollars shall be one-half as much more as they are under the table of fees with the fifty per cent. added thereto, and on the trial of every suck last mentioned action and on every argument before the Court, or before the Judge at Chambers, in every such action the Judge may allow a counsel fee of not less than Five Dollars nor more than Forty Dollars in his discretion.

5. The provisions under Part IV, of Chapter 188 of the Consolidated Statutes 1903, in regard to fees of counsel is repealed.
