

29. North Forks of Bass River, Kent County 5
Description: Vacancy in Block 5, Range 10.
30. St. Nicholas River 3
Description: Vacancy bounded southerly by grants to P. McAulry, G. Brooks, H. Johnston and Samuel Brown; westerly by road up E. Br. St. Nicholas River and grants to J. & T. Curran, A. Hudson, J. & A. Little, northerly by grants to J. Looney, Wm. Little and No. 27, Wm. Brait jr., easterly by grants to Jas. Smith, Wm. Scott and J. McGowan in Galloway Sett., excepting lots 73 and 74 western side of Chockpish road.
31. Parishes of St. Marys and Weldford, Kent County 8½
