To carry on the business of hotel, tavern, restaurant, lodging and public house keepers or proprietors, public caterers, coach, livery stable, garage and jitney service proprietors, caterers for all kinds of amusements, entertainments, dinners and social functions of all kinds, hair-dressers, messengers, and any other business which may appear capable of being profitably or conveniently carried on in connection with or as auxiliary to the hotel business.

To enter into contracts with entertainers, and manage, own and operate a theatre or house of entertainment.

To purchase, manufacture, sell and deal in tobaccos and foods of every nature and kind whatsoever, cutlery, plate, linen, furniture, electric light fittings, live and dead stock, produce and liquids of every description, and any other commodities goods or effects convenient for the purposes of the Company, or for any of the aforesaid purposes.

To erect, construct, purchase, lease or otherwise acquire, or deal in, equip, furnish, work, operate, let and maintain any hotel or hotels, clubs, taverns, refreshment rooms, shops, buildings, premises, garages, stables, places of amusement or recreation.

To purchase or otherwise acquire and obtain provisional or other protection and licenses in respect of any inventions or alleged inventions, patents, trade-marks or names, designs, copyrights, schemes, ideas, secret or other processes, and the like, whether in the Dominion of Canada or elsewhere, which may appear likely to be advantageous or useful to the company, and to test, develop, prolong, renew, exercise, use, vend, grant exclusive or other licenses in respect of, or otherwise deal with all or any of the same.
