"GANDY & ALLISON, LIMITED"

PUBLIC NOTICE is hereby given that under "The New Brunswick Companies' Act, 1916" and amending Acts Letters Patent have been issued under the seal of the Provincial Secretary-Treasurer of the Province of New Brunswick, bearing date the Twentieth day of December, A. D. 1921, incorporating G. E. Chester Gandy, Merchant; Harold A. Allison, Merchant; V. Arthur Gandy, Clerk; Elizabeth R. Gandy, Married Woman; and T. Gwendoline Allison, Married Woman; all of the City of Saint John in the City and County of Saint John and Province of New Brunswick for the following purposes, namely:

To acquire and take over as a going concern the business now carried on by the said G. E. Chester Gandy and the said Harold A. Allison at the City of Saint John in the County of the City and County of Saint John in said Province under the name, style and firm of "Gandy & Allison" with all real estate, stock-in-trade and the good-will thereof and all the rights and contracts now held by the said business, subject to the obligations affecting the same, and to pay for the same in paid-up shares of the Company or otherwise.

To carry on the business of a general export and import commission and shipping agent and to acquire for that purpose the business, rights, franchise, connection and good-will of any person, firm or corporation carrying on or interested in any similar business.

Colter, Married Woman; all of the City of Fredericton in the County of York and Province of New Brunswick for the following purposes, namely:

To carry on the business of manufacturing, buying, selling, trading in, bartering and dealing in all kinds of goods, wares and merchandise, both wholesale and retail, and for such purposes or any of them, or any purpose incidental thereto, or connected therewith.
