And whereas a duly certified copy of a resoution passed by the Legislative Assembly of the Province of New Brunswick in accordance with such provision was received by the Secretary of State of Canada on the 9th day of April 1921;

And whereas an order of Our Gover-General in Council has been passed directing that the votes of all the elec-tors of the said Province of New Bruns-wick be taken for and against the aforesaid prohibition,-

Now know ye that We do hereby, in virtue of the authority vested in Us by the said Act and Order in Council proclaim and deciare that, on Monday the lith day of October next, A.D. 1921, a poll will be held in the said Province of New Brunswick for taking the votes of the electors of that Province for and against the said prohibition. That such votes will be taken as defined and provided for by the Dominion Elections Act, between the hours of eight o'clock, in the forenoon and six o'clock in the afternoon of that day and by fallot.
