Stuart Edwards WHEREAS in Actg Deputy Minister of by section 152 Justice, Canada of the Canada Temperance Act, being Chapter 152 of the Revised Statutes of Canada, as amended, it is amongst other things in effect enacted that upon the receipt by the Secretary of State of Canada of a duly certified copy of a resolution passed by the Legislative Assembly of any Province n which there is at the time in force a law prohibiting the sale of intoxicating liquor for beverage purposes, reall the electoral disitricts of the province may be taken for and against the following prohibition, that is to say,—That the importation and the bringing of intoxicating liquors into such province may be forbidden—Our Governor in Council may Shippegan.

issue a proclamation appointing a day for the taking of the votes of the electors of such province for and against such

And whereas a duly certified copy of a resoution passed by the Legislative Assembly of the Province of New Brunswick in accordance with such provision was received by the Secretary of State of Canada on the 9th day of April 1921;

And whereas an order of Our Gover-nor General in Council has been passed directing that the votes of all the elec-tors of the said Province of New Bruns-wick be taken for and against the aforesaid prohibition,-

Now know ye that We do hereby, in virtue of the authority vested in Us by the said Act and Order in Council proclaim and declare that, on Monday the joth day of October next, A.D. 1921, a political be held in the said Province of New Brunswick for taking the votes of the electors of that Province for and against the said prohibition. That such votes will be taken as defined and provided for by the Dominion Elections. Act, between the the Dominion Elections Act, between the hours of eight o'clock, in the forenoon and six o'clock in the afternoon of that day and by ballot. That the following persons have been appointed the Returning Officers, respectively, for the several electoral districts of the said Province for the purpose of taking on that day the votes of the electors for and against the saild prohibition:
