WHEREAS, the Legislative Assembly of this Province stands prorogued to Thursday, the Seventh day of July inst. I have thought fit further to prorogue the said Legislative Assembly, and the same is hereby prorogued accordingly, to Thursday, the Twenty-fifth day of August next.

Given under my hand and seal at Fredericton the Sixth day of July, in the year of Our Lord one thousand nine hundred and twenty-one, and in the Twelfth year of His Majesty's Reign.

A PROCLAMATION

W. Stuart Edwards WHEREAS in Actg. Deputy Minister of by section 152 Justice, Canada, of the Canada Temperance Act, being Chapter 152 of the Revised Statutes of Canada, as amended, it is amongst other things in effect enacted that upon the receipt by the Secretary of State of Canada of a duly certified copy of a resolution passed by the Legislative Assembly of any Province in which there is at the time in force a law prohibiting the sale of intoxicating liquor for beverage purposes, requesting that the votes of the electors in all the electoral districts of the province may be taken for and against the following prohibition, that is to say,—That the importation and the bringing of intoxicating liquors into such province may be forbidden—Our Governor in Council may

issue a proclamation appointing a day for the taking of the votes of the electors of such province for and against such prohibition;

And whereas a duly certified copy of a resolution passed by the Legislative Assembly of the Province of New Brunswick in accordance with such provision was received by the Secretary of State of Canada on the 9th day of April 1921;

And whereas an order of Our Governor General in Council has been passed directing that the votes of all the electors of the said Province of New Brunswick be taken for and against the aforesaid prohibition;—

Now know ye that We do hereby, in virtue of the authority vested in Us by the said Act and Order in Council proclaim and declare that, on Monday the 10th day of October next, A.D. 1921, a poll will be held in the said Province of New Brunswick for taking the votes of the electors of that Province for and against the said prohibition. That such votes will be taken as defined and provided for by the Dominion Elections Act, between the hours of eight o'clock, in the forenoon and six o'clock in the afternoon of that day and by ballot. That the following persons have been appointed the Returning Officers, respectively, for the several electoral districts of the said Province for the purpose of taking on that day the votes of the electors for and against the said prohibition:—

Charlotte—Harry M. Webber, Esquire

St. Stephen.

Gloucester—Martin J. Robichaud, Esquire, Shippegan.

Kent—George A. Hutchinson, Esquire, Barrister, Richibucto.

Northumberland—Charles E. Fish, Esquire, Newcastle.

Restigouche and Madawaska—James Edward Stewart, Esquire, Dalhousie.

Royal—St. Clair Fraser, Esquire, Chipman.

St. John City and Counties of St. John and Albert—Amon A. Wilson, Esquire, Sheriff of the City and County of St. John, St. John.

Victoria and Carleton—Edmund C. Morgan, Esquire, Hartland.

Westmorland—George B. Willett, Esquire, Moncton.

York-Sunbury—John B. Hawthorne, Sheriff of the County of York, Fredericton.

And further know ye that the said Returning Officers are empowered and required to appoint a Deputy Officer at and for each polling place or station in the electoral districts for which they are severally appointed. That the said Returning Officers, will, on Wednesday the 5th day of October next, 1921, at ten o'clock in the forenoon appoint persons to attend at the various polling stations and at the final summing up of the votes on behalf of persons interested in and promoting or opposing, respectively, the adoption of the prohibition, such appointments to be made for the several electoral districts at the following places, respectively:—

Charlotte—At the Curling Rink, at St. Stephen.

Gloucester—At the Municipal Hall, at Shippegan.

Kent—At the Court House, at Richibucto.

Northumberland—At the Court House at Newcastle.

Restigouche and Madawaska—At the Court House, at Dalhousie.

Royal—At the Court House, at Gagetown.

St. John City and Counties of St. John and Albert—At the Court Rooms, Masonic Hall, 96 Germain Street, St. John.

Victoria and Carleton—At the Court House, at Woodstock.

Westmorland—At the Court House, at Dorchester.

York-Sunbury—At the Court House, at Fredericton.

And further know ye that the votes of the electors will be summed up and the result of the polling declared by the Returning Officers at the places next aforementioned respectively, on Tuesday, the 18th day of October next, 1921, at ten o'clock in the forenoon and that in the event that the vote of the electors of the said Province of New Brunswick shall be in favour of the said prohibition, such prohibition shall go into force on such day and date as shall by Order in Council under section 189 of the Canada Temperance Act be declared.

Of all which Our loving subjects and all others whom these presents may concern, are hereby required to take notice and to govern themselves accordingly.

In Testimony Whereof We have caused these Our Letters to be made Patent and the Great Seal of Canada to be hereunto affixed. Witness: The Honourable John Idington, one of the Judges of the Supreme Court of Canada and Deputy of Our Right Trusty and Right Entirely Beloved Cousin and Counsellor, Victor Christian William, Duke of Devonshire, Marquess of Hartington, Earl of Devonshire, Earl of Burlington, Baron Cavendish of Hardwick, Baron Cavendish of Keighley, Knight of Our Most Noble Order of the Garter; One of Our Most Honourable Privy Council; Knight Grand Cross of Our Most Distinguished Order of Saint Michael and Saint George; Knight Grand Cross of Our Royal Victorian Order; Governor General and Commander-in-Chief of Our Dominion of Canada.

At Our Government House, in Our City of Ottawa, this Ninth day of July, in the year of Our Lord one thousand nine hundred and twenty-one, and in the twelfth year of Our Reign.
