

LETTERS PATENT GRANTED

MARITIME CONSTRUCTION CO., LTD.

PUBLIC NOTICE is hereby given that under "The New Brunswick Companies' Act, 1916," and amending Acts, Letters Patent have been issued under the seal of the Provincial Secretary-Treasurer of the Province of New Brunswick, bearing date the twenty-fifth day of February, A. D. 1921, incorporating Murray W. Long, Contractor; Harry B. Tippett, Accountant, and Joseph L. O'Brien, Manager, all of the Parish of Lancaster, in the County of the City and County of Saint John, and Province of New Brunswick, for the following purposes, namely:

To carry on the business of constructing all erections, buildings or structures and more particularly construct bridges, culverts, conduits, tramways, streets, sidewalks, pavements, sewers, water and gas pipe lines, breakwaters and embankments and piers, made up of earth, sand, stone, brick, cement, concrete, wood, iron, steel or other materials or metals either wholly or in part.

To carry on the business of manufacturing and producing all kinds of building materials from cement, concrete and other materials, including bricks, blocks, tiles and pipe.

To carry on the business of quarrying, excavating and removing earth, sand, rock and other materials.

To carry on the business of lumbering in all its branches and to manufacture, purchase, hire or otherwise dispose of lumber of all kinds, and all goods, wares and merchandise used in connection therewith.

To carry on a general mercantile business, and purchase or otherwise acquire, sell and dispose of and deal in goods, wares and merchandise of all kinds.

To purchase, lease or otherwise acquire all lands, timber licenses and privileges, quarries, mines, water powers and rights which the company may deem necessary or desirable for any of the above purposes or otherwise, and to sell or otherwise dispose of the same or any part thereof as may seem advisable.

To build, purchase, lease or otherwise acquire, maintain and operate and sell, hire, or otherwise dispose of saw-mills, machine shops, factories, wharves, docks, booms, piers and warehouses.

To carry on the business of building, repairing, purchasing, leasing, chartering or otherwise acquiring, operating and maintaining and selling, hiring, chartering or otherwise disposing of ships, tugs, lighters, barges, scows and all other vessels and all gear and equipment therefor.

To do any of the above things as principal, agent, contractor or by or through trustees or agents or otherwise.

To amalgamate with any other company or companies having objects in whole or in part similar to those of the said company.

To sell, lease, let, exchange or otherwise encumber or deal with the undertaking of the Company, or with the real and personal property of the company or any part thereof, for such consideration as the Company may deem fit.

To acquire any other business similar to its own and to enter into agreements for sharing profits, joint adventures or other arrangements of like nature with other persons, firms or corporations carrying on a similar or like business or allied to the said business of this company.

PUBLIC NOTICE is hereby given that under "The New Brunswick Companies' Act, 1916," and amending Acts, Letters Patent have been issued under the seal of the Provincial Secretary-Treasurer of the Province of New Brunswick, bearing date the twenty-fifth day of February, A. D. 1921, incorporating Harry W. Mann, Lumberman; William A. McVay, Contractor; Allan M. A. McLean, Accountant; Randall J. Webber, Manager, and P. Elmer McLaughlin, Barrister all of the Town of Saint Stephen in the County of Charlotte and Province of New Brunswick, for the following purposes, namely:

To carry on the business of general contractors, constructors and builders.

To carry on the business of manufacturers of and dealers and workers in cement and the by-products thereof, and artificial stone and other articles composed in whole or in part of Portland or other cement, or the by-products of the same.

To carry on the business of quarrymen.

To search for, quarry, mine and make merchantable, manufacture, use, buy, sell and deal in stone, artificial stone, brick, marl, shale, slate, clay, gravel, sand, lime, plasters, coal, coke, fuel and other minerals, metals and earths, Portland and other cements, and all articles composed of all or any of the same, in whole or in part, or of all of the by-products thereof, in whole or in part.

To acquire, construct and purchase tugs, scows, barges, dredges, ferry boats, steam boats, wharves and vessels of every kind which may be used or required in the business of general contractors and builders and dealers in materials incidental thereto.

To purchase or otherwise acquire and undertake all or any of the assets, business, property, privileges, contracts, rights, obligations and liabilities of any company, society, partnership or person carrying on any part of the business which this Company is authorized to carry on, or possessed of property suitable for the purposes of this company, and to pay for the same in cash or in shares of this Company, or partly in cash and partly in shares.
