SUPPLEMENTARY LETTERS PATENT GRANTED

CONSUMERS COAL CO., LIMITED.

PUBLIC NOTICE is hereby given, that under The New Brunswick Companies' Act, 1916, and amending Acts, Supplementary Letters Patent have been issued under the seal of the Provincial Secretary-treasurer, bearing date the twenty-eighth day of April, A. D. 1921, whereby the capital stock of "Consumers' Coal Co., Limited," has been increased from forty-nine thousand dollars to one hundred and twenty-four thousand dollars; such new stock to be divided into seven hundred and fifty shares of one hundred dollars each, two hundred and fifty of such shares to be preference stock and when issued to rank pari passu with the twenty-five thousand dollars of preference stock heretofore issued and all such preference stock shall hereafter be called first preference stock and five hundred of such shares to be second preference stock, which shall be entitled to a fixed preferential cumulative dividend of 7 p. c. per annum to be fully paid after the dividends on the first preference stock are fully paid, and before any dividends are paid on the common stock, and shall be entitled in the distribution of assets of the Company or in the winding up thereof, to be paid in full after the first preference stock shall have been paid before any part of the common stock shall be paid, but such second preference stock shall have no voting power except that the holders thereof shall have the right to be represented on the board of directors by one director to be elected by them; hereby cancelling anything heretofore granted to the said Company by Letters Patent, inconsistent herewith, and amending the same accordingly.
