HOUSE OF ASSEMBLY

RULES AND PRACTICE OF THE LEG. ISLATIVE ASSEMBLY OF NEW BRUNSWICK.

THE attention of parties intending to seek legislation at the next session of the Legislative Assembly is directed to the following Rules:

Private and Local Bills

77. A typewritten copy or printed copy of every Private Bill or Local Bill intro-duced into this House shall be filed with the Clerk of the House within ten days after the opening of the Session, and in case of failure to comply with this pro-vision, the fee on the introduction of any vision, the fee on the introduction of any such Private Bill shall be double the fee provided for in Rulé 84, applicable to such Bill, and Local Bills introduced after ten days of the opening of the Seasion shall pay the same fee as a Private Bill.

78. Not Private Bill, or Bill making an amendment of a like nature to a fermer Act, shall be received by the House unless a potice specifying clearly and discontinuous.

mer Act, shall be received by the House unless a notice specifying clearly and distinctly the nature and objects thereof, has been published four successive weeks previous to the meeting of the Legislature, or to the introduction of the Bill in some one of the newspapers published in the County, interested in or to be affected by the measure, or in the locality where the parties affected, or the majority of them reside; and when no newspaper is published in such county or lecality, then in some newspaper having QUEENS
