Private and Local Bills

A typewritten copy or printed copy of every Private Bill or Local Bill intro-luced into this House shall be filed with the Clerk of the House within ten days after the opening of the Session, and it are of failure to comply with this proand in vision, the fee on the introduction of such Private Bill shall be double the fee provided for in Rule 84, applicable to such Bill, and Local Bills introduced after ten days of the opening of the Session shall pay the same fee as a Private Bill.

78. No Private Bill, or Bill making

an amendment of a like nature to a for-her Act, shall be received by the House unless a notice specifying clearly and dis-tinctly the nature and objects thereof has been published four successive weeks previous to the meeting of the Legisla-ture, or to the introduction of the Bill in some one of the newspapers published in the County, interested in or to be af-fected by the measure, or in the locality where the parties affected, or the major ity of them reside; and when no news-paper is published in such county or lo-cality, then in rome newspaper having general circulation in such County or lo cality, and also in the Royal Gazette. When the City or County interested in the measure, or the locality in which the measure, or the locality in which the parties affected reside, is largely composed of a French population, then such-notice shall also be published in a French newspaper, if any be published in the

79. In any County where no newspaper may be published, the Bill, in lieu of other local publications, may be read at any Circuit or County Court in the presence of the Grand Jury, or before the Municipal Council of the County interested in or affected by the Hill, and a certifi-cate of such reading shall be indowsed thereon, or attached to the said Bill, by the Clerk of the Court, or the Town Clerk or the Secretary-Tressurer, as the case may be, verified by the Seel (if any) of the Court, Town Council or Municipal Council as the case may be; and a pe-tition must be presented to the House setting forth in detail the object of the measure, and the reasons that may be urged for its adoption.
