Ordered, on the recommendation of the Honourable the Minister of Health that Health Regulation No. 145 be amended by adding the following after the word "building" in the last line of said

regulation:--"Where construction or other work of any kind is being carried on and where the number of workmen so employed in any definite work or place is twenty or more, and where such workmen or the majority of them have residence apart and at a distance from said work, it shall be the duty of the contractor or

contractors carrying on such work, or of the manager concerned, to provide suitable privies for such workmen, and such privies shall be readily accessible to the workmen concerned, and shall be so located, and of such character and so located, as shall be satisfactory to the maintained as shall be satisfactory to the Medical Health Officer of the Health District in which such work is being carried on, or to any sanitary inspector, deputed by him, or by the sub-district Board of Health concerned, to examine and pronounce upon such convenience."

The Board of Commissioners of the General Public Hospital, St. John, N. B. have passed certain by-laws which have been approved:

Second Portion, Section 1, Chapter 11.— Should the first Wednesday of the month fall on a public holiday, then the regular meeting shall be held on the Wednesday of the following week at the same hour.

Section 2, Chapter IV.—
The Commissioners shall elect a visiting staff consisting of:

(a) Legally qualified Senior Physicians

not exceeding (4), and legally qualified Junior Physicians, not exceeding four (b) Legally qualified Senior Surgeons, not exceeding four (4), and legally qualified Junior Surgeons, not exceed-

ing four (4).
(c) Three (c) Three (3) legally and specially outlified medical men, who shall act as Oculists, Aurists, Rhinologists and

Oculists, Aurists, Laryngologists. A Pathologist and an Pathologist.
(e) A Radiographer and an Assistant

Radiographer.

Section 3.— The Commissioners may appoint two (2) legally qualified surgeons as Alternate Surgeons, until the claims of the Visiting Physicians, made at the time of the adoption of this section are met. The Alternate Surgeons shall supply during the absence of a regular Senior Surgeon, and shall attend surgical consultations.

Section 4— The Junior Surgeons shall assist Senior Surgeons, attend the Surgical Out-

Patients, and perform such other sur-gery as their Senior Surgeons shall direct. The Junior Physicians shall attend the Medical Out-Patients, and perform such other duties in connection with the Medi-cal work of the Hospital, as their Seniors may direct.

Section 5 .---No Physician or Surgeon shall be con-sidered ellgible to remain on the Visiting Staff after he has attained the age of years

sixty years.

That sections 3, 4, 5, 6, 7 and 8 be respectively numbered 6, 7, 8, 9, 10 and 11. Section 5., Chapter IV—

The words "at the regular meeting in July" to be deleted.

That Section 3 of Chapter VII of the Bylaws of the General Public Hospital be repealed and the following adopted in lieu thereof: Section 3: The visiting Commis—

sioner shall receive or reject applicants for admission as in his discretion he shall think advisable, having regard to the existing circumstances of the Hospital; but he shall admit no person without previous examination by the Superintendent or his Deputy. sioner shall receive or reject applicants That Section 5, Chapter X is hereby re-

realed. That Section 15 of Chapter XII is hereby

repealed and the following adopted in lieu thereof:

Section 15. He shall examine all patients applying for admission and shall admit or reject such applicants at his discretion unless his decision is disap-

proved by the Visiting Commissioner.

He shall determine whether a person applying for admission as a patient shall be received as a free or a pay patient and in the latter case he shall agree upon the price to be paid weekly and shall take such security as he may deem requisite to the regulations of the Board of Commissioners

Section 4. Chapter XIV-She shall have control of Nurses both on and off duty, whether belonging to the establishment or not, and shall have power to suspend any nurse for cause, pending the result of a report to the Training School Board.

Section 9, Chapter XIV—
Outside Nurses may be allowed to attend pirvate patients in the Hospital when from any cause there may be an insufficient number on the establishment, but such Nurses must conform to the Hospital Regulations and to the directions of the Lady Superintendent.

Section 8 of Chapter XVI. is hereby amended by adding after the word "dismissal" the words "by the Superintendent or the Visiting Commissioner".

Section I of Chapter XVII. is hereby amended by adding after the word "Commissioner" on the first line of the section, the following "or any qualified physician or surgeon of the County of the City and County of Saint John."

Section 6 of Chapter XVII. is hereby amended by striking out the words "Attending Physician" and adding in lieu thereof "Superintendent or his Deputy".

By-Law regulating the traffic and the use of the roads or streets in the Vil-

use of the roads or streets in the Village of Rothesay.

Whereas the Village of Rothesay by virtue of an Act of the Legislative Assembly of New Brunswick, being Chapter 16, 12 George V. 1922, is authorized and empowered to make By-Laws and regulations to regulate the traffic and the use of the roads or streets in the village.

Therefore be it enacted as a By-law of the said Village as follows:

1. No person having charge of a motor vehicle shall drive same within the village, faster than at a rate of speed of
