HIS HONOUR THE LIEUTENANT GOVERNOR has been pleased to approve of the following bye-laws: "By-law regulating the use of the roads in Wilmot Park, in the City of

Fredericton.

Whereas, "The Wilmot Park Board" by virtue of an Act of the Legislative Assembly of New Brunswick, being Chapter 55 of 58 Victoria (1895), is authorized and empowered to make by-laws and regula-tions, as they may deem proper, in order to carry into execution and enforce the powers vested in the said Board, to be in force only within and in respect to the said Wilmot Park;

Be it therefore enacted as a by-law of the said Wilmot Park Board as follows

1. No person having charge of any

and pedestrians on the highway, and shall exercise all possible care not to injure persons using the said Park. 3. The said Board shall have power to

declare closed any and all roads within the said Park to motor vehicle or carriage traffic, when it deems it desirable to do so, and notice of such declaration shall be posted at the entrance and exit of the road declared closed.

road declared closed. 4. Any person offending against any of the provisions or regulations of these by-laws shall, for every such offence, be liable to a penalty not exceeding forty dollars and not less than five dollars. 5. These by laws shall come into ef-
