SPEECH

Mr. Speaker and Gentleman of the Legislative Assembly:

In bringing the present session to a close and relieving you from further attendance. I desire to express my deep appreciation of the diligent attention which you have given to the discharge of your Legislative duties.

In addition to the Acts of a private character which have been passed, you have been asked to consider important legislation and measures for the prosperity and good government of the Province. Included in these are: An Act to Consolidate the Various Statutes of the Province, An Act to Consolidate the Rates and Taxes Act, An Act to Amend the Workmen's Compensation Act, An Act amending the New Brunswick Hydro Electric Act, and An Act amending the New Brunswick Electoral Districts Act.

I wish to thank you for the liberal of Moncton Assessment Act, 1921". provision you have made for the several services of the Province.

I now relieve you from your Legislative duties and in bringing this session to a close, permit me to extend

individual prosperity and happiness. Clerk Keefe announced that the House would stand prorogued until Thursday, May 8th.
