By His Honour William F. Todd, LL. D., Lieutenant-Governor of the Province of New Brunswick.

WILLIAM F. TODD

Whereas, the Legislative Assembly of this Province stands prorogued to Thursday, the Sixth day of August next, I have thought fit to dissolve the said Legislative Assembly, and the same is hereby dissolved accordingly.

And I have thought fit further to order and direct that Writs for calling a new Legislative Assembly, to meet on the Tenth day of September next, be forthwith issued in due form, returnable forthwith to our Provincial Secretary-Treasurer at Fredericton.

Given under my hand and seal at Fredericton, the Seventeenth day of July, in the year of our Lord one thousand nine hundred and twenty five, and in the Sixteenth year of Our Reign.
