## PROCLAMATION

By His Honour William F. Todd, LL. D., Lieutenant-Governor of the Province of New Brunswick.

WHEREAS, the Legislative Assembly of this Province convened on Thursday the 11th day of March last, and continued its sittings until this day, being the 30th day of April instant, I have thought fit to prorogue the said Legislative Assembly, and the same is hereby prorogued accordingly to Thursday the 10th day of June next.

Given under my hand and seal at Fredericton the 30th day of April, in the year of our Lord one thousand nine hundred and twenty six, and in the sixteenth year of His Majesty's reign.

Under and by virtue of Section 29 of Chapter 6 of the Acts of the Legislative Assembly, 16 George the Fifth, 1926, entitled "An Act Respecting Theatres, Cinematographs and other Amusements" and of an order-in-council thereunder made dated the 27th day of May, A. D. 1926, and pursuant to the power and authority thereby in me vested, I do hereby order and declare that the said Chapter of said Acts shall come into force on, from and after the first day of June in the year of our Lord One Thousand, Nine Hundred and Twenty-six.

Given under my hand and seal at Fredericton the twenty-seventh day of May, in the year of our Lord One Thousand, Nine Hundred and Twenty-six and in the sixteenth year of His Majesty's reign.

The Lieutenant-Governor-in-Council under The Theatres, Cinematographs and other Amusements Act is pleased to make the tariff of fees to be paid under said Act for annual licenses as follows:

### LICENSES

1. Every owner, lessee or other occupant having possession or control of any

theatre shall before any performance is given therein first obtain a license (herein called a theatre license) under these regulations.

2. Every film exchange and every user exhibitor or operator and every apprentice to an operator of a cinematograph shall obtain a license under these regulations.

3. Before any cinematograph is used in any performance there shall be obtained from the Board of Censors a certificate that such is a certified cinematograph under these regulations. Such certificate shall be called a machine certificate.

4. Every amusement owner having possession or control of any place of amusement shall before an amusement is conducted therein obtain a license under these regulations.

5. Every application for a license or certificate under these regulations shall be made to the Provincial Secretary-Treasurer. Before granting such license or certificate, the Board of Censors may make such investigation into the circumstances of the application as may appear necessary, and if satisfied that the applicant is entitled thereto the Provincial Secretary-Treasurer shall, on payment of the fee herein prescribed, issue a license or certificate in the form in the schedule.

6. All licenses or certificates issued under these regulations shall expire on the first day of June in each year, and all annual licenses or certificates issued hereunder shall be in force for one year following date of issue. The fees payable for such licenses or certificates shall be as follows:

1. For every film exchange .....\$250.00
2. For each reel of film, not more than 1,100 feet submitted to the New Brunswick Board of Censors, an additional fee of ..... 1.50
3. For every additional hundred feet or fraction thereof ..... .15
4. For appeal from the decision of the Board a fee of \$5.00 per reel shall be paid.
5. For every cinematograph or moving picture machine used, for machine certificate ..... 5.00
6. Every owner, lessee or occupant of a theatre, and every owner, user, or exhibitor, of every cinematograph shall pay the following fees:

(a) In all villages and towns with a population not exceeding 1,500.... .05 cts. per seat.

(b) In all towns over 1,500 population and up to 3,000 ..... 10 cts. per seat.

(c) In all towns over 3,000 population and up to 7,500 ..... 15 cts. per seat.

(d) In all towns or cities over 7,500 population ..... 20 cts. per seat.

(e) In all villages, towns or cities where not more than three performances are given in any week one half the fee as set in section (a) to (d) inclusive shall apply.

(f) Operators of cinematographs shall pay a license fee of .....\$2.00

(g) Apprentices ..... 1.00

(h) All persons other than those who have paid a license for film exchanges, submitting film for censorship, shall pay for each reel of film censored a fee of ..... 5.00

The fees payable for amusement licenses are as follows:

For every assembly room, dance hall, billiard hall, concert hall, rink, athletic park, race track, bowling alley, shooting gallery, tent, enclosure used as a place of amusement respectively.

In a village or town with a population not exceeding 5,000 a fee of ....\$1.00 per year.

In a village or town with a population over 5,000 a fee of ..... 2.00 per year.

The Lieutenant-Governor-in-Council under the New Brunswick Companies Act and Acts in amendment thereof is pleased to make the tariff of fees to be paid under section 117.

For filing annual returns under section 117 of the Companies Act as amended, amendment act 1926, the fee payable upon each return shall be as follows:

Companies with an authorized capital not exceeding \$25,000 .....\$ 5.00  
Companies with an authorized capital exceeding \$25,000, but not exceeding \$50,000 ..... 10.00  
Companies with an authorized capital exceeding \$50,000, but not exceeding \$100,000 ..... 30.00  
Companies with an authorized capital exceeding \$100,000, but not exceeding \$250,000 ..... 40.00  
Companies with an authorized capital exceeding \$250,000, twenty cents for
