To purchase, own, produce and present, and to license others to present and produce theatrical plays and operas.

To acquire and hold, sell, assign and transfer copyrighted and uncopyrighted plays and operas.

To purchase, own, procure, construct and acquire theatres or buildings for the purpose of operating cinemas and motion picture shows and performances.

To purchase, lease, acquire and hold land for the construction thereon of theatres, play houses or music halls, within the Province of New Brunswick, and to give public or private performances of any kind therein for the entertainment of the public.

Generally to do all things usual, customary and necessary for the proper carrying out the successful operation of theatres, picture houses, play houses or mus-ic halls, by the name of "Windsor The-atres, limited" with a capital stock of Sixty-Five Thousand Dollars divided into Six Hundred and Fifty Shares of which Five Hundred are to be Preferred Stock of the par value of One Hundred Dollars each; which said stock shall have no voting power but shall be entitled to a cumulative dividend in each year of an amount equal to Seven per cent of the amount actually paid in on the said stock payable from the profits, if any, and shall not be entitled to participate in any other additional earnings or profits. In case of liquidation or dissolution of the Company the holders of the Preferred Stock shall be entitled to receive cash to the amount of their preferred stock at par before any payment in liquidation is made upon the general or common stock, and shall not thereafter participate in any of the property of the Company or proceeds of liquidation.
