Letters Patent Granted

"A. F. RANDOLPH & SONS, LIMITED"

PUBLIC NOTICE is hereby given that The New Brunswick Companies' Act, 1916" and amending Acts, Letters Patent have been issued under the seal of the Provincial Secretary-Treasurer of the Provincial Secretary-Treasurer of the Province of New Brunswick bearing date the Eighth day of September, A. D. 1926, incorporating Robert FitzRandolph, Merchant; Robert S. FitzRandolph, Mer-chant; both of the City of Fredericton, in the County of York and Province of New Brunswick; Guy A. FitzRandolph, Lum-berman; and Archibald M. FitzRandolph, Lieutenant in His Majesty's Royal Air Force; both of Randolph, in the County of Saint John and Province aforesaid; for

the following purposes, namely: To acquire and take over as a going concern the wholesale grocery business heretofore carried on at the City of Fredericton, under the name and style of A. F. Randolph & Sons with all the assets. stock-in-trade and real and personal property owned or used in connection therewith, and the good-will thereof, and all the rights and contracts now held by them, subject to the obligations, if any, affecting the same; and to pay for the same in paid-up shares of this Company; and to carry on the said business in all its branches and to extend the same as to the Directors may from time to time seem expedient.

To carry on the business of whole-sale and retail merchants in all its branches.

To make, manufacture, purchase, sell, job in and otherwise deal in goods, wares and merchandise of all descriptions within the Province of New Brunswick or elsewhere.

To purchase, take or otherwise acquire and hold shares in any other company having objects altogether or in part similar to those of the Company or carying on any business capable of being conducted so as to directly or indirectly

to benefit the Company.

To purchase, take on lease or in exchange hire or otherwise acquire, any real or personal property and any rights or privileges therein which the Company may think necessary or convenient for the purposes of its business.

To do all such things as the Company

is entitled by law to do.

To do all such other things as are incidental or conducive to the attainment of the above objects, by the name of "A. F. Randolph & Sons, Limited" with a capital stock of One Hundred and Seventy Thousand Dollars divided into Twelve Hundred Preference Shares of One Hundred Dollars each, and Five Hundred dred Dollars each, and Five Hundred Common Shares of One Hundred Dol-lars each. The Preference Shares shall pay a dividend of Six pay a dividend of Six per cent per annum payable semi-annually which dividend shall be cumulative; and in a dis-tribution of assets the holders of Preference Shares shall be entitled first to repayment of the Preference capital at its par value and secondly to payment out of the assets of the arrears (if any) of the Preferential dividend; and the sur-plus assets shall be divided between the

holders of the Common stock. The Preference Shares shall have and carry no voting power at any meeting of Shareholders of the Company unless and until the dividends thereon are in arrears and unpaid for six months, when the holders of such Preference shall have the ordinary voting rights of

Shareholders. The Preference Shares may be re-
