HIS HONOUR THE LIEUTENANT GOVERNOR has been peased to order, on the recommendation of the Honourable the Minister of Health that the following

Regulations be adopted:

Regulations for Raw Milk—(Grade A.)

Notwithstanding any regulations of any sub-district Board of Health it shall be lawful to sell, hold for sale and offer for sale for human consumption in the Province of New Brunswick milk and cream to be known as Paw Milk or Raw cream to be known as Raw Milk or Raw

Cream—Grade A. which conforms to the following regulations:

1. It shall be taken from a herd, all animals of which have been subjected annually to the Tuberculin test and certi-fied without reaction. Such tests to be made by a veterinary surgeon in the employ of the Provincial Department of Agriculture or one approved by the Sub-District Board of Health.

All animals failing to pass such Tuberculin test shal be disposed of at once under the direction of the said veterinary surgeon.

Raw mik, Grade A. shall (unless otherwise specified in these regulations) conform to the standards provided, and be produced and handled strictly cordance with the regulations of the Department of Health of N. B. regarding "Dairies and Milk."

2. It shall be free from blood, pus.

sediment or disease producing organisms 4. It shall be free from disagreeable

odor or taste. It shall be evoled to 55 degrees F or under, within one hour after milking and kept at or below that temperature until defivered to the consumer.

It shall, immediately after being

cooled, be bottled in sterile bottles and shall be immediately sealed.
7. It shall be plainly labelled Raw Milk-Grade A. with the name of the dairyman producing same.

Every person whose work brings

Every person whose work brings him or her in regular contact with the production or handling of Raw Milk—Grade A. shall hold a certificate from a regularly qualified physician certifying to the fact that within three months laboratory and other examinations have been made indicating that said person is free from tuberculosis, that said person is not a carrier of typhoid and that said person is free of any disease capable of being

spread through milk supplies.

9. Any dealer licensed or permitted to sell Raw Milk—Grade A. shall send notice to the District Medical Health Officer within 24 hours of any case of sickness or any infectious, contagious or communicable disease occuring among the persons employed upon his dairy, farm, or the members of his household.

10. Provided that no milk shall be sold, offered for sale, held for sale, supplied or in the possession of a licensed milk vendor, as Raw Milk—Grade A. until such vendor shall have compiled with all the regulations of the Department of

all the regulations of the Department of Health, respecting dairies and milk and these regulations and shall have received a permit from the Board of Health to supply such Raw Milk—Grade A.

11. Provided always that any infringment of those regulations, or of the regulations of the Department of Health respecting Dairies and Milk will be sufficient to revoke or cancel the permit or ficient to revoke or cancel the permit or all permits given to a milk producer. 12. In these regulations the term

"mik" shall include "cream."
13. These regulations shall apply only to producers or their agents being bona fide producers selling direct to consumers.
