"SAINT JOHN BRICK COMPANY, LIMITED".

PUBLIC NOTICE is hereby given that under "The New Brunswick Companies' Act, 1916", and amending Acts, Letters Patent have been issued under the seal of the Provincial Secretary-Treasurer of the Province of New Brunswick, bearing date the Fourth day of August, A. D. 1926 incorporating Fred Harley Colwell, Finan-

cier; Alice Maud Colwell, Married Woman; and Thomas Louis McGloan, Barrister-at-Law; all of the City of Saint John, in the County of Saint John and Province of New Brunswick; for the following purposes, viz.,

To carry on the business of commission agents, importers, exporters and also of manufacturers of bricks, tiles, pipes, pottery, earthenware, china, terra cotta, ceramic ware of all kinds, fire brick, stove linings, locomotive bricks, artificial stone and all products of like nature and to import, buy, sell and otherwise deal with the same.

To carry on the business of masons, builders and contractors and to construct, acquire, own, operate, manage, deal in and dispose of buildings, works and real estate in such manner and upon such terms as the Company may deem fit.

To purchase, lease or otherwise acquire any quarries, mines, mining rights or mining lands or any interest therein and to explore, work, exercise, develop and turn to account the same, and to crush, win, get, quarry, calcine, refine, manipulate, prepare for market, use, buy, sell and deal in any stone, sand, lime, marl, shale, slate, clay, gravel and other minerals required for the Company's operations.

To provide, purchase, lease or otherwise acquire and to construct, erect, establish, install, operate, maintain and carry out all necessary works, mills, plant, machinery and equipment of every kind necessary or suitable for the Company's business.

To draw, take, accept, endorse, discount, execute and issue promissory notes, bills of exchange, bills of lading, warrants, debentures, warehouse receipts or other negotiable or transferable instruments.

To raise or borrow money for the purposes of the Company or any of them on such terms, in such manner and in such amounts as the Company shall think fit, by the name of "Saint John Brick Company, Limited," with a capital stock of forty-nine thousand dollars divided into four hundred and ninety shares of one hundred dollars each, with the head office at the Parish of Simonds in the County of Saint John and Province of New Brunswick.

date the Sixth day of August, A. D. 1926 incorporating E. Le Roi Willis, Gentleman; Sherman L. Colpitts, Telegrapher; and James C. Lawton, retired; all of the City of Saint John, in the County of Saint John and Province of New Brunswick; for the following purposes, namely:

To conduct and carry on the manufacture and sale of drugs, chemicals, medicines, patent and proprietary medicinal preparations and to do all things necessary or incidental thereto.

To acquire all and any receipts and processes for the purpose of manufacturing and the right to manufacture and deal in all medicinal preparations and patent medicines, and to carry on the manufacture and sale of any such medicines and preparations and generally to carry on the business of manufacturers, buyers and sellers of and dealers in all kinds of medicines, medicinal preparations and drugs whatsoever.

To conduct and carry on the business of chemists, druggists, dyers, oil and colour men, importers, manufacturers and dealers in pharmaceutical, medicinal, chemical, industrial and other preparations and articles, compounds, cements, oils, paints, pigments and varnishes, drug dye ware, paint and colour grinders, makers and dealers in proprietary articles of all kinds and all electrical, chemical, photographic, surgical and scientific apparatus and material.
