

Canada or in any other Country which may seem capable of being used for any of the purposes of the Company or otherwise and which may seem calculated directly or indirectly to benefit the Company and to use, exercise, develop or grant license in respect of or otherwise to turn to account the property rights or information so acquired.

To manufacture, buy, sell, improve, treat, preserve, refine, aerate, mineralize and otherwise deal in mineral and aerated waters and other liquids of every description.

To extract and mine from the earth petroleum oil and any and all other soils, minerals (including natural gas) and other products and to refine, manufacture and work petroleum oil and other oils, minerals and other products.

To acquire, buy, sell, dispose of, trade and deal in petroleum oil and other oils, paints, paint, stocks, varnishes, boiler compound and products, wares and articles wholly or partly made of or produced from oil and any kind and also natural gas.

To acquire by purchase, lease, concession, license, exchange or other legal title to mines, mining lands, easements, mineral properties or any interest therein, minerals, ores and mining claims, options, powers, privileges, water rights, patent rights, letters patent of invention, processes and medicinal and other contrivances, and to work, exercise, develop and turn to account and either absolutely or conditionally and either solely or jointly with others or as principal, agents, contractors, or otherwise to sell, refine and deal in oil, gas and other minerals of all kinds and to lease, mortgage, place under license, hypothecate, sell, dispose of and otherwise deal with the same or any part thereof or any interest therein.

To prospect and explore in all parts of Canada and elsewhere for minerals of every sort and description, whatsoever with a view to locating and acquiring mines and mining rights and operating the same.

To amalgamate with or join with any individual, firm or corporation in any similar business or undertaking.

To carry on business as manufacturers and dealers in plant machines, machinery, vessels, syphons, filters, bottle apparatus, appliances and receptacles of all kinds for the manufacturing, improving, treating, preserving, fining, aerating, mineralizing, bottling and discharging of any such products.

To carry on the trade or business of warehousemen, samplers, traders, packers and carriers of personal property of every description.

To carry on the business and to act as merchants, brokers, traders, commission merchants, general agents, ship owners, or in any other capacity and to import, export, buy, sell, barter, exchange, pledge, make advances upon or otherwise deal in goods, produce, articles and merchandise.

To sell and dispose of the undertakings of the Company or any part thereof for such consideration as the Company may think fit and in particular to sell and dispose of the undertakings of the Company or any part thereof for shares, debentures or securities of any other company having objects altogether or in part similar to those of the Company.

To sell, improve, manage, develop, exchange, lease, mortgage, enfranchise, dispose of, turn to account or otherwise deal in and with all or any part of the property and rights of the Company.

To purchase, lease or otherwise acquire, hold, sell and otherwise dispose of, in whole or in part, the bonds, capital stock, business, goodwill, rights, franchises, property and assets of every kind of any persons, corporation or corporations conducting a business within the purposes of this Company, and to pay for the same in money or in stock or bonds of the Company or otherwise and to assume in whole or guarantee in whole or in part the liabilities of such person or persons, corporation or corporations, whose business may be acquired by the Company and to exercise all the rights, powers and privileges of ownership including the right to vote thereon.

To acquire by purchase, lease, exchange or otherwise lands, buildings and hereditaments in the Province of New

Brunswick or elsewhere and to sell, mortgage or otherwise dispose of land, tenements, hereditaments, to erect, alter, repair and maintain buildings upon the said lands in which the Company may have an interest or otherwise.

To buy, lease or otherwise acquire and hold, sell, and otherwise dispose of real estate and to act as real estate brokers and agents.

To carry on any other business of a similar nature or any business which in the opinion of the Directors may be conveniently carried on by the Company, by the name of "The Ezy Oil Company, Limited," with a capital stock of forty-nine thousand dollars divided into two classes, namely: Thirty thousand dollars Class "A" Stock, being Preference Stock and priority as respects assets and Winding Up Only, divided into thirty thousand shares of one dollar each, and nineteen thousand dollars, class "B" Stock, being Ordinary Stock of the Company divided into Nineteen Thousand shares of one dollar each.

The Class "A" Stock being Preference Stock is preferred as to assets only under Winding up or upon Bankruptcy when the said stockholders are to be paid in full before the holders of common shares participate in monies realized on the assets of the Company, and is not entitled to vote at Shareholders' Meetings of the Company but are entitled to participate equally with the ordinary stock in the profits of the undertaking of the Company with the head office at Fairville, in the County of the City and County of Saint John and Province of New Brunswick.

All timber, logs, or other lumber cut upon unlicensed Crown Land, or which may be cut by any person beyond the limits of his own berth, shall be seized and forfeited to the use of the Crown; and no timber or lumber shall be cut on any berth applied for until it shall be purchased at public auction.
