Regulations—The New Brunswick Liquor Contrio Board.

Regulations made by the New Brunswick Liquor Control Board and assented to by the Chief Commissioner this third day of August, 1927, and approved by the Lieutenant-Governor-in-Council this third day of August 1927.

1. (a) In all regulations or forms made or provided by the Board, the words, expressions and phrases used therein, shall unless the context otherwise requires, be construed as required by "The Intoxicating Liquor Act, 1927."

(b) "Act" shall mean "The Intoxicating Liquor Act, 1927."

2. (a) All accounts payable by the Board shall be approved by the Board or

Board shall be approved by the Board, or by some member of the Board or official thereof designated by the Board for that

purpose in writing.

((b) All cheques made or issued by the Board shall be signed by the Chief Commissioner, or by some official of the Board designated by him for that purpose in

writing.

3. (a) The corporate seal of the Board shall be in the following form and

(b) Such seal shall be affixed to documents requiring the seal of the Board only in the presence of the Chief Commissioner or of some official designated by him in writing, and shall be attested by the signature of the Chief Commissioner or of such official such official.

4. All officers and officials of the Board shall, if and as required by the Board, furnish approved surety bonds for the proper performance of their duties in such amounts and subject to such terms and conditions as the Board was the Board. The cost of such bond shall be and conditions as the Board may

paid by the person so bonded.

5. It shall be the duty of the travelling auditors appointed by the Board:

(a) To inspect and audit from time to time the accounts, moneys and records of the managers or other officials in charge of or connected with government stores, or of any other officials of the Board, as directed by the Board or by the Chief Commissioner.

(b) To report the results of all such inspections and audits to the Chief Commissioner.

(c) To report to the Chief Commissioner any contravention of the Act or of the regulations made thereunder, that may come to their notice.

6. It shall be the duty of a manager appointed by the Board to

(d) To perform such other acts or duties as the Board or the Chief Commission-

(a) Regulate and apportion the work amongst the staff provided, and supervise all matters connected with the receiving

and distributing of liquor on the premises of the store under his charge.

(b) Take all necessary precautions for safeguarding liquor in stock, moneys, fixtures, equipment and property of the Board under his charge.

(c) Conduct the store under his charge in accordance with the instructions issued from time to time to him by the Board to be known as instructions to

(d) Conform to all instructions is-(d) Conform to all instructions issued from time to time by the Board through the Chief Commissioner or other duly authorized member or officer, relating to the nature and quantity of liquor which may be sold at any one time, the price at which such liquor may be sold and the accounting for all moneys received and distributed by the manager on behalf of the Board. half of the Board.

(e) Make himself familiar with the provisions of the Act and the Regulations made thereunder, particularly insofar as they relate to the conduct and management of Government Liquor Stores and govern himself accordingly.

(f) At all times render courteous service consistant with proper enforcement of the Act and the regulations made thereunder, in the management of the store under his direction.

(g) Preserve order upon the premis-

store under his direction.

(g) Preserve order upon the premises of the store under his direction, and permit no minor, disorderly persons, persons of bad character, or any other persons not legally authorized to purchase liquor at such store, to be in or upon such store or premises, and no person shall remain on the premises longer than the necessary time to make their purchase.

(h) Refuse any tip or gratuity from

any person.

(i) File all prescriptions filled at such store, and keep a register of all such sales under prescriptions, in the form pre-scribed by the Board, and indicating the such date of the sale, the name of the pur-chaser, the quantity of liquor sold, and the name and qualifications of the phys-

ician prescribing such iquor.

7. Any medical prescribed by such danager may be retained by such manager before supplying any liquor thereunder for such time as may be necessary to enable the Manager to ascermether the same was signed by the medical practitioner by whom it purports are signed and whether it is in other re-

medical practitioner by whom it purports signed and whether it is in other respects bona fide.

8. The Managers of Government Stores shall affix the official seal of the rei to each container of wine not already bearing such seal and for that purpose the Board shall supply the managers of the stores with such seals.

9. A Manager may deliver liquor to an agent of a person duly authorized to purchase the same provided such agent produces to the manager written authority to receive such liquor, such authority
