Under and by virtue of the Act of the Legislative Assembly of New Brunswick nassed in the year 1927 intituled "An Act to revise and consolidate the General Public Statutes of New Brunswick", and pursuant to the power and authority thereby in me vested. I hereby order and declare that The Revised Statutes 1927 shall come into and be in force and effect on, fro mand after the sixteenth day of February in the year of our Lord one thousand nine hundred and twenty-eight. Given under my hand and seal at Frederaction the fourteenth day of December in the year of our Lord one thousand nine hundred and twenty-seven and in the eighteenth year of His Majesty's reign.

HOUSE OF ASSEMBLY

Rules and Practice of the Legislative Assembly of New Brunswick.

The attention of parties intending to seek legislation at the next session of the Legislative Assembly is directed to the following Rules:

Private and Local Bills

Private and Local Bills

77. A typewritten copy or printed copy of every Private Bill or Local Bill introduced into this House shall be filed with the Cierk of the House within ten days after the opening of the Session, and in case of failure to comply with this provision, the fee on the introduction of any such Private Bill shall be double the fee provided for in Rule 84, applicable to such Bill, and Local Bills introduced after ten days of the opening of the Sesson shall pay the same fee as a Private Bill.

78. No Private Bill, or Bill making an amendment of a like nature to a former Act, shall be received by the House unless a notice specifying clearly and distinctly the nature and objects thereof.

er Act, shall be received by the House unless a notice specifying clearly and distinctly the nature and objects thereof, has been published four successive weeks previous to the meeting of the Legislature, or to the introduction of the Bill in some one of the newspapers published in the County, interested in or to be affected by the measure, or in the locality where the parties affected, or the majority of them, reside: and when no newspapers ity of them, reside; and when no news-paper is published in such county or locality, then in some newspaper having general directation in such County or lo-cality, and also in the Royal Gazette. When the City of County interested in the measure, or the locality in which the par-ties affected reside is largely composed of a French population, then such notice shall also be published in a French news-paper, if any be published in the Prov-

ince.

79. In any County where no newspaper may be published, the Bill. in lieu of other local publications may be read at any Circuit or County Court in the presente of the Grand Jury, or before the Minicipal Council of the County interested in or affected by the Bill, and a certificate of such reading shall be indorsed the reon, or attached to the said Bill, by the Clerk of the Court, or the Town Clerk, or the Secretary-Treasurer, as the case may be, verified by the Seal (if any) or the Court. Town Council or Municipal Council, as the case may be; and a petition must be presented to the House so what forth in detail the object of the measure, and the reasons that may be urged for its adoption.

20. When any Bill affects Civil or Market Clivil or Market Clivil

Municipal interests, a notice distinctly

specifying the purposes and objects of the Bill shall, at least one week before the introduction of such Bill into the House, be delivered to the Secretary-Treasurer of the County or to the Clerk of the City or Town which may be affected, and due proof of such notice shall be made by affidavit.

81. It shall be the duty of all parties seeking the interference of the Legislature in any Private Bill, to file with the Clerk of this House the evidence of their having compiled with the Rules and Standing Orders thereof.

82. In default of such proof or evidence being so furnished, it shall be the duty of the Clerk to report to Mr. Speaker, or the House, and to indorse upon the Bill that the Rules and Standing Orders have not been complied with.

84. No Private or Local Bill shall be received unless it shall be certified by the Deputy Provincial Treasurer upon the Bill, or by certificate annexed thereto, that there has been received into the Provnicial Treasury towards the printing and other contingent expenses of the House, the following:

On all original Bills not exceeding one page, \$50.00.

For each additional page or part of a page, \$10.00.

On all amending Bills not exceeding one page, \$30.00.

For each additional page or part of a page, \$10.00.

Upon Incorporation of Companies hav-

page. \$10.00.

Upon Incorporation of Companies having a stated capital, or amendments increasing capital, an additional fee equal to the fee payable under the N. B. Joint Stock Company's Act.

A page, for the purposes of this Bule, shall mean not exceeding 500 words.
