By His Honour, the Honourable William F. Todd, LL. D., Lieutenant-Governor of the Province of New Brunswick.

Given under my hand and seal at Fredericton the 27th day of September, in the year of our Lord one thousand nine hundred and twenty-eight, and in the nineteenth year of His Majesty's Reign.

WHEREAS it hath pleased Almighty God in His great goodness to vouchsafe this year to Our Dominion of Canada, a bountiful harvest and other blessings. We, therefore, considering that these blessings enjoyed by Our People throughout the Dominion do call for a solemn acknowledgement, have thought fit by and with the advice of Our Privy Council for Canada to appoint, and We do appoint MONDAY the twelfth day of November, 1923, (Armistice Day) as the day of General Thanksgiving to Almighty God for the bountiful harvest and other blessings with which Canada has been favoured this year and We enjoin all Our loving subjects throughout Canada to observe the said day as a day of thanksgiving. In Testimony Whereof, We have caused these Our Letters to be made Patent and the Great Seal of Canada to be hereunto affixed. Witness: Our Right Trusty and Well-beloved Cousin Freeman Viscount Willingdon, Knight Grand Commander of Our Most Exalted Order of the Star of India, Knight Grand

Cross of Our Most Distinguished Order of Saint Michael and Saint George, Knight Grand Commander of Our Most Eminent Order of the Indian Empire, Knight Grand Cross of Our Most Excellent Order of the British Empire, Governor General and Commander-in-Chief of Our Dominion of Canada.

At Our Government House, in our City of Ottawa, this nineteenth day of September, in the year of Our Lord one thousand nine hundred and twenty-eight and in the nineteenth year of Our Reign.

"WESTMORLAND MOTORS, LIMITED"

Public Notice is hereby given that under "The New Brunswick Companies' Act (being Chapter 88 of the Revised Statutes of 1927), Letters Patent have been issued under the seal of the Provincial Secretary-Treasurer of the Province of New Brunswick, bearing date the Thirteenth day of October A. D. 1923, incorporating F. Lansdowne Belyea, Accountant; George I. Higgins, Accountant; both of the City of Saint John in the County of the City and County of Saint John and Province of New Brunswick; and J. Howe Knox, Salesman; of the City of Moncton, in the County of Westmorland and Province aforesaid; for the following purposes, namely:

To buy, sell or otherwise acquire or deal in, automobiles, automobile parts, accessories, supplies, gasoline, oils or all other commodities connected with the business of garagemen or incidental thereto.
