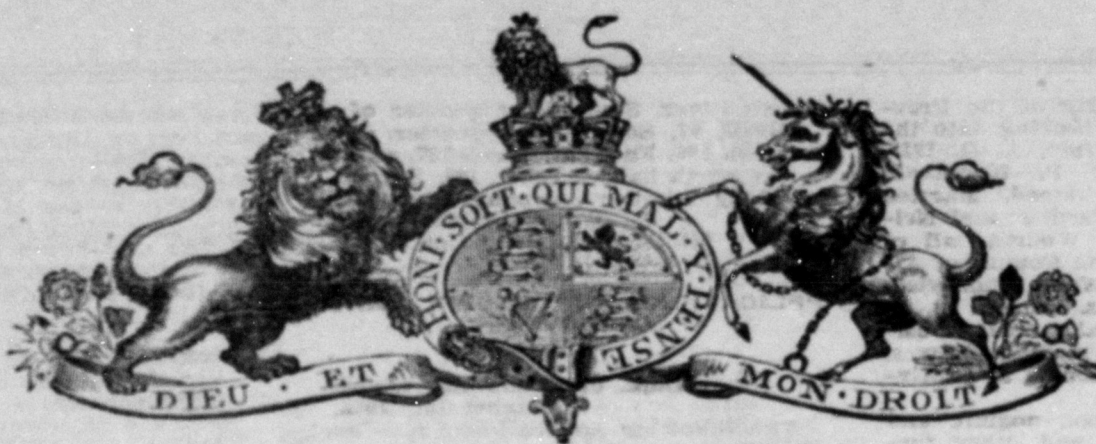

By His Honour, the Honourable William F. Todd, LL. D., Lieutenant-Governor of the Province of New Brunswick.

WILLIAM F. TODD

WHEREAS, the Legislative Assembly of this Province stands prorogued to Thursday the 19th day of July, I have thought fit to further prorogue the said Legislative Assembly, and the same is hereby prorogued accordingly to Thursday the 30th day of August next.

Given under my hand and seal at Fredericton the 13th day of July, in the year of our Lord one thousand nine hundred and twenty-eight, and in the nineteenth year of His Majesty's Reign.
