HIS HONOUR THE LIEUTENANT GOVERNOR has been pleased to order that the following regulations made by the New Brunswick Liquor Control Board be approved:

44 (1) The Costs in all prosecutions under The Intoxicating Liquor Act, 1927, shall be the same as in The Summary Convictions Act.

(2) The costs on appeals to a Judge of the County Court shall be the same as on Review in The Summary Convictions Act: but in no case shall they exceed fifteen dollars; (3) The Court of Appeal, on hearing

and determining an appeal from a Coun-ty Court Judge, may, in its discretion, grant costs to either party, such costs to e not less than \$25.00 and not to exceed \$50.00.

45. When any vehicle, motor car, au-tomobile, vessel, boat, canos or convey-ance which has been selzed by the police under this Act and has not been claim-ed by the owner or his respresentative, the saidi vehicle, motor car, automobile, vessel, boat, canoe or conveyance shall after a period of thirty days from the date of such seizure be forfested to His Maj-esty in the right of the Province.
