In any County where no news-paper may be published, the Bill in lieu of other local publications may be read at any Circuit or County Court in the pres-ence of the Grand Jury, or before the Municipal Council of the County interest-ed in or affected by the Bill, and a certificate of such reading shall be indorsed thereon, or attached to the said Fill, by the Clerk of the Court, or the Town Clerk, or the Secretary-Treasurer, as the case may be, verified by the Seal (if any) of the Court, Town Council or Municipal Council, as the case may be; and a petition must be presented to the House setting forth in detail the object of the measure, and the reasons that may be urged for its adoption.
