"HARVEY WELTON, LIMITED"

Public Notice is hereby given that under "The New Brunswick Companies' Act" (being Chapter 88 of the Revised Statutes 1927), Letters Patent have been issued under the seal of the Provincial Secretary-Treasurer of the Province of New Brunswick, bearing date the Sixth day of November A. D. 1929, incorporating Richard B. Hanson, King's Counsel; Charles L. Dougherty, Barrister-at-Law;

and William J. West, Barrister-at-Law; all of the City of Fredericton, in the County of York and Province of New Brunswick; for the following purposes, namely:

To purchase, acquire and take over as a going concern from Harvey Welton, the coal mining business and undertaking now carried on by him at Minto and Canning in the Counties of Sunbury and Queens, together with all the assets, stock-in-trade, plant, equipment and real and personal property owned or used in connection therewith and the good-will thereof, and all the rights and contracts now held by him in connection therewith subject to the obligations, if any, effecting the same, and to pay for the same in paid up shares in this Company.

To prospect for, open, explore, develop, work, improve, maintain and manage mines, quarries, mineral and other deposits and properties, and to win, raise and treat ores, metals and mineral substances of all kinds, whether belonging to the Company or not, and to render the same merchantable and to sell and otherwise dispose of the same, or any part thereof, or any interest therein.

Generally to carry on the business of a mining, milling, reduction and development Company.

To acquire by purchase, lease, concession, licenses, exchange or other legal title, mines, mining lands, easements, mineral properties or any interest therein, minerals and ores, and mining claims, options, powers, privileges, water and other rights patent rights, processes and mechanical or other contrivances, and either absolutely or conditionally, and either solely or jointly with others, and as principals, agents, contractors or otherwise, and to lease, place under license, sell, dispose of and otherwise deal with the same or any part thereof or any interest therein.
