To manufacture the goods above referred to parts thereof or materials contained therein.

To act as agents for other dealers or manufacturers in any of the above mentioned merchandise.

To acquire by purchase, lease, ex-change, grant or otherwise, and to hold. improve, develop, rent, sell, exchange, lease, or otherwise dispose of and generialy to deal in all lands and real estate of all and every kind and description and all rights, estates and interests therein.

To borrow or raise or secure the pay-ot of money in such manner as the

as owner or by way of collateral security. or otherwise, and to sell, guarantee the sale of and to assign, transfer or otherwise dispose of or deal in bonds, debentures and other evidence of indebtedness, stocks, shares and other securities of any government or municipal or school corporation, or of any banking, public util-ity, commercial, industrial or other company or corporation or individual or association.
