

commendation thereon to the Attorney General. The Attorney General may thereupon give his decision in the matter respecting the seizure, detention, penalty or forfeiture, and the terms, if any, upon which the thing seized or detained may be released.

The Attorney General may authorize the Board to exercise the powers conferred upon the Attorney General by this Regulation.

The owner, or agent, or claimant of the thing seized or detained may, with the consent of the Attorney General, appeal from the decision of the Attorney General or the Board, such appeal to be in the form set forth under Section 136, Sub-sections 1 and 2, and Section 117 of The Intoxicating Liquor Act. There shall be delivered to the Attorney General and also to the Board notice of such appeal, with an affidavit of the owner, agent or claimant of the thing seized or detained.

NEW TIMBER APPLICATIONS.

Dept. of Lands and Mines,

Licenses to expire on the first of August, 1930 but subject to renewal with first of August 1933, in accordance with Chapter XI, 3 George V., 1913, for Saw Mill Licenses of the following applications for Timber Berths, for the purpose of cutting all classes of lumber, will be sold at this Department on Thursday the 29th day of August, 1929, at noon.

Upset price \$20. per square mile in addition to stumpage.

There is no payment of any bonus required. Licenses are renewable each year by payment of \$5. per square mile and fire tax of \$3.20 per square mile, stumpage in accordance with the regulations in force and subject to annual change.

All timber, logs or other lumber cut upon unlicensed Crown Land or which may be cut by any person beyond the limits of his own berth shall be seized and forfeited to the use of the Crown; and no timber or lumber shall be cut on any berth applied for until it shall be purchased at public auction.

REGULATION GOVERNING FISHING.

On Waters Within the Becaguimac Game Refuge.

Dept. of Lands and Mines,
Fredericton, August 22nd, 1929.

No person shall enter upon the Becaguimac Game Refuge for the purpose of fishing without a fishing permit which may be issued by the Minister of Lands and Mines subject to the following conditions:

1. The Permit shall be good only between May 15th and August 31st inclusive.
2. No fish less than eight inches in length may be retained.
3. Not more than thirty fish shall be taken from the Refuge on any one trip.
4. FEES: Resident \$1. for the season.
Non-resident must pay regular fee of \$10 for a trout license and must also have a Woods Travel Permit.
5. Any person violating any of the provisions of this regulation will be liable to a penalty of not less than \$10, and not more than \$50 for each offence, and in default of payment thereof to imprisonment not exceeding one month.

BECAGUIMAC GAME REFUGE.

Public notice is hereby given that the following described area is set apart as a Game Refuge, to take effect on and after September first, 1929. This area is situated in the Parishes of Brighton and Northampton in the County of Carleton and in the Parish of Southampton in the County of York, and more particularly described as follows:

Beginning at a point on the northern side of the right-of-way of the Gibson Branch of the Canadian Pacific Railway at Shewan Station, the said point being the intersection of the above mentioned railroad with the right-of-way of the abandoned narrow gauge railroad to Hartland, thence in a north easterly di-

rection along the eastern side of the said right-of-way of the said abandoned railroad, a distance of four miles more or less, to the southern side of the Pole Hill road so called thence in an easterly direction along the southern side of the said Pole Hill road, a distance of 5.75 miles, more or less, to the western bank or shore of the South Branch Becaguimac River the said point being opposite to the dividing line between lot No. 36 granted to Chares Crabb and lot No. 37 granted to John R. Hoyt in Cloverdale Settlement, thence along the said bank or shore in a southerly direction following its various courses to the western side of the highway road from Cloverdale to Mapleton, thence in a southerly direction along the said western side of the said last mentioned highway, a distance of four miles, more or less, to its intersection with the north western side of the lumber road leading to Nackawic station, thence in a westerly direction along the north western side of the said lumber road a distance of four miles, more or less, to the northern side of the right-of-way of the Gibson Branch of the Canadian Pacific Railway at Nackawic station thence along the said northern side of the said right-of-way in a north westerly direction, a distance of nine miles, more or less, to the place of beginning and containing forty-three square miles, more or less, and distinguished as the Becaguimac Game Refuge.

No person has the right to hunt or trap for or disturb game, fur-bearing animals or birds found within the limits of this game refuge, or travel upon it with either a gun or dog at any time.

The penalty provided for hunting or trapping within a game refuge is \$300 or six months imprisonment.

"Candidates shall be British subjects, shall be over twenty-two years of age and shall satisfy the examiners that they have had at least two years' experience in scaling and measuring logs before being permitted to take the examinations". (Sub-section 4, Chap. 33).
