

THE LIEUTENANT-GOVERNOR-IN-COUNCIL under the Theatres, Cine-matographs and other Amusements Act is pleased to amend the regulations made on the 29th day of October, A. D. 1926, as follows: as follows:

For every billiard hall, bowling al-ley and shooting gallery used as a place of amusement respectively:

In a village or town with a population not exceeding 5000 a fee of \$2.00 per year for every billiard or pool table, bowling alley, shooting gallery, payable as the Inspector determines in each particular case.

In a vilage or town with a population over 5000 and not exceeding 10,000 a fee of \$5.00 per year for every billiard or pool table, bowling alley, shooting gallery, payable as the Inspector determines in each particular case.

In a city with a population over 10,000 a fee of \$5.00 per year for each of the first two billiard or pool tables, bowl-

ing aliey, shooting gallery, and for each billiard or pool table, bowling aliey, shooting gallery over that number, the sum of \$7.50 for every billiard or pool table, bowling alley, shooting gallery, payable as the Imspector determines in each particular.

Clubs and fraternal benefits associa-tions having billiard hall, bowling alleys and shooting galleries for the use only of their members shall not be subjected to any such tax.

Every billiard hall, bowling alley and shooting gallery paying the above tax shall be exempt from the amusement tax.
