

Letters Patent

"TAYLOR AND WHITE, LIMITED"

PUBLIC NOTICE is hereby given that under "The New Brunswick Companies' Act" (being Chapter 88 of the Revised Statutes 1927), Letters Patent have been issued under the seal of the Provincial Secretary-Treasurer of the Province of New Brunswick, bearing date the Twentieth day of September, A. D. 1930, incorporating James D. Taylor, Cooper; G. Frederick White, Cooper; and James B. Dever, Barrister-at-Law; all of the City of Saint John, in the County of the City and County of Saint John and Province of New Brunswick; for the following purposes, namely:

To purchase, take over or otherwise acquire as a going concern the coopeage business now carried on at the City of Saint John aforesaid by the said James D. Taylor and the said G. Frederick White and all or any of the assets and liabilities of the said business in connection therewith together with the undertaking and good-will thereof and all the rights and contracts now held or engaged in connection with the said business, subject to the obligations, if any, effecting the same, and to pay for same in paid-up shares of this Company.

To carry on a general business in the manufacture, sale and distribution of barrels, boxes and other similar receptacles and containers made in whole or in part of wood material pulp or other material.

To manufacture for sale and deal in the raw materials required by the Company or any of them and in connection with the same to carry on the trade and business of lumber, wood-worker and saw-miller.

To remunerate by payment in cash, stock, bonds or other manner any person or persons or corporation or corporations for services rendered or to be rendered, in placing or assisting to place, or guaranteeing the placing of any of the shares of stock of the Company, or in or about the formation or promotion of the Company, or in the conduct of its business.

To distribute in specie or otherwise, as may be resolved, any assets of the Company among its members, and particularly the shares, bonds, debentures or other securities of any other company properly obtained by this proposed Company.

To take or otherwise acquire and hold shares in any other company having objects altogether or in part similar to those of the Company or carrying on any business capable of being conducted so as directly or indirectly to benefit the Company.

To sell or dispose of the undertaking of the Company or any part thereof for such consideration as the Company may think fit, and in particular for shares or securities of any other company having objects altogether or in part similar to those of the Company.

To do all or any of the above things and all things authorized by the Letters Patent as principals, agents, contractors, trustee or otherwise and either alone or in conjunction with others.

To do all such things as are incidental or conducive to the attainment of the above objects, by the name of "Taylor and White, Limited", with a capital stock of Twenty Thousand Dollars divided into Two Hundred Shares of One Hundred Dollars each, with the head office at the City of Saint John, in the County of the City and County of Saint John and Province of New Brunswick.
