REGULATIONS FOR FOX PENS OR RANCHES.

No foxes shall be kept within the limits of the City of Moncton. In towns, incorporated villages, thickly settled and build up portions of the County; no fox ranch, or pens shall be established or maintained, in which foxes are intended to be kept, without a written permit from Sub-district Board of Health con-cerned, and no such permit shall be cerned, and no such permit shall be issued by such Board, for the keeping of such animals within 100 feet of any neighbors inhabited house, centre of street or public highway, and in every instance of a fox ranch or pens being maintained, such fox ranch or pens shall be kept in a shall be kept in a sanitary condition and in conformity with such regulations or bye-laws, relating thereto as the Sub-district Board concerned may, from time to time, lay down in accordance with law.
