"JACOBSON & EVERETT, LIMITED."

Public Notice is hereby given that under "The New Brunswick Companies' Act" (being Chapter 88 of the Revised Statutes of 1927), Letters Patent have been issued under the seal of the Provincial Secretary-Treasurer of the Province of New Brunswick, bearing date the Twenty-first day of March, A. D. 1930, incorporating Barnet Jacobson, Merchant; Hyman Barney Everett, Merchant; Esther Jacobson, Married Woman and Esther G. Everett, Married Woman; all of the City of Saint John, in the County of the City and County of Saint John and Province of New Brunswick, for the following purposes, namely:

To purchase, acquire and take over all the stock-in-trade, good-will, fixtures, equipment and effects of the businesses now conducted by the said Barnet Jacobson at No. 459 Main Street in the City of Saint John, under the name of "Barnet Jacobson" and that conducted by the said Barney Hyman Everett at No. 667 Main Street in the said City of Saint John under the name of "Barney's" and all interest in said businesses and to carry on the business of the same.

To buy, sell, import, export and to generally deal in and with all kinds of textile goods, wares and merchandise, and to prepare, manufacture and deal in all kinds of dry-goods, cloths and textile fabrics and garments and other manufactures of the same.
