"THE RIDGEWOOD GOLF CLUB LIMITED"

PUBLIC NOTICE is hereby given that under "The New Brunswick Companies" Act" (being Chapter \$3 of the Revised Statutes 1927), Letters Patent have been issued under the seal of the Provincial Secretary-Treasurer of the Province of New Brunswick, bearing date the Twenty-Fifth day of August A. D. the Twenty-Fifth day of August, A. 1936, incorporating Andrew S. Allen, Re-tired, Albert E. Massie, Merchant, and Frederick A. Day Salesman, all of the City of Saint John, in the County of the City and County of Saint John and

Province of New Brunswick for the fol-

lowing purposes, namely,

To promote, organize, conduct and manage a golf, country and social club and to promote the welfare of the memhers thereof, with power to make and adopt a constitution, by-laws, rules and regulations for the admission, suspension and expulsion of its members and their government, and for the establishment of different classes of membership and for the collection of fees and dues,

To appoint committees to manage the affairs of the corporation with power to adopt and enforce rules and regulations therefor.

To provide a club house and other conveniences for the use of the bers of the club and to furnish and maintain the same and to permit the same to be used by members of the said club and their guests, either gratuitously or upon such terms as may from time to time be agreed upon, and also to be used by the public upon such terms as may be decided upon, and generally to do what-ever may be best calculated to promote the interests of the Club.

To acquire by purchase or otherwise, hold, develop and sell real estate or any interest therein.

In addition to the promotion of the game of golf, to promote the sports tennis, bowling swimming, boating and such other sports as may be conveniently carried on, on to the property of the Company,

To become a member of and cooperate with any other association

club having similar objects. To buy, sell, and deal in all kinds of

sporting equipment. To raise money by subscription, and to grant any rights and privileges to the supluscribers.

To establish and carry on schools for instruction in the various sports conductand to charge fees therefor.

To issue paid-up shares, bonus, debenture stock and or other securities for the payment, either in whole or in part of the purchase price of any property, real or personal, claims, privileges, licenses, concessions, franchises, or other advantages which the Company may lawfully acquire, and for services rendered to or work petformed for the Company, and also to issue such fully paid-up shares, bonds, debenture stock and or other securities in payment or part payment or exchange for the shares, bonds or debenture stock and or other securities of any other company.

And it is ordained and declared that the shareholders of the Company may by resolution remove any director or directors or any officer or officers before the expiration of his or their period of office and appoint another qualified person in his or their stead for the balance of his

or their term, at any special meeting of which notice specifying the intention to pass such resolution shall

have been given.

with power to hold meetings of share holders, directors—and executive committee of directors (if any) at any place whether within or without New Brunswick by the name of "The Ridgewood Golf Club, Limited" with a capital stock consisting of the hundred Member shares of the pay value of One Hundred Dollars (\$100.00) each and one thousand (1,000) (\$100.00) each and one thousand (1,000) common or ordinary shares without nominal or par value. The Member shares shall be entitled to a preferential dividend (non cumulative) of seven per cent (7 p. c.) fer annum, but the holders thereof shall not be entitled to vote so long as the said dividend is earned and reald

The common or ordinary shares without nomnial or par value may be issued by the Directors, fully paid and non assessable, as a bonus in consideration of the subscription to and payment of Mem-ber shares, in the proportion of one com-mon or ordinary share for each Member share. The remaining five hundred (500) common shares may be issued and allotted by the Directors from time to time for such consideration as may be fixed by the Directors at the time of allotment not exceeding in amount or value, as determined by the Directors, the sum of

In accordance with Section 7 of the New Brunswick Scaler's Act (Chapter 33, Revised Statutes 1927) examinations for New Brunswick's Scaler's License will be held on Wednesday, September 10th, 1930 at the offices of the Department of Lands and Mines, Fredericton, beginning at 9

"Candidates shall be British subjects, shall be over twenty-two years of age and shall satisfy the examiners that they have had at least two years' experience in scaling and measuring logs before being per-mitted to take the examinations." (Subsection 4, Chap. 33).
