NOTICE OF LEGISLATION

Notice is hereby given that the Town of Dalhousie will at the next session of the Legislative Assembly of New Brunswick, make application for the passing of an act to authorize the said Town of Dalhousie to issue debentures to a sum not exceeding Twenty-five Thousand Dollars (\$25,000) for the purpose of providing general permanent improvements in the Town including fire station and apparatus, the opening and constructing of new streets, roads and sidewalks, and building permanent sidewalks and streets in said Town; and also to authorize and empower the Town of Dalhousie in each and every year to borrow temporarily or until the rates and taxes are collected in such year a sum or sums of money not exceeding in all the sum of Fifteen Thousand Dollars (\$15,000) from a chartered bank or otherwise and when the said rates and taxes are collected the sums so borrowed shall be repaid.
