BANTALOR GAME REFUGE

Public notice is hereby given that as a Game Refuge to take effect on and after September the 1st, 1920. This area is situated in the Parishes of St. Mary's and Stanley in the County of York and more particularly described as

REGULATIONS, GOVERNING ANG-LING, ON WATERS WITHIN THE BANTALOR GAME REFUGE.

No person shall enter upon Banta-lor Game Refuge for the purpose of fishing without a fishing permit which may be issued by the Minister of Lands and Mines subject to the following con-

ditions.

1. Permit shall be good only be-tween May the 15th and August 31st in-

clusive. 2. No fish less than 8 inches in

length may be retained.

2. Not more than thirty (30) fish shall be taken from the Refuge in any one trip.

Fees, Residents \$1.00 for season. Non-residents must pay regular fee of \$10.00 for trout license and must have a Woods Travel Permit.

5. Any person violating any of the provisions of this regulation is liable to a penalty of not less than \$10.00 and not

more than \$50.00 for each offence and in default of payment to imprisonment not exceeding one month.
