Letters Patent

"GENERAL REALTY COMPANY, LIMITED"

Public Notice is hereby given that under "The New Brunswick Companies' Act" (being Chapter 88 of The Revised Statutes 1927) and amending Acts, Letters Patent have been issued under the

seal of the Provincial Secretary-Treasurer of the Province of New Brunswick bearing date the Sixteenth day of September, A.D. 1931, incorporating, Horace Alfred Porter, Barrister-at-Law; Louis McCoskery Ritchie Barrister-at-Law; and Agnes Josephine Crowley, Clerk; all of the City of Saint John, in the County of the City and County of Saint John and Province of New Brunswick for the following purposes, namely:

To act as real estate agents, developers and promoters and in such connection to acquire by purchase, lease, exchange, concession or otherwise any description of real estate and real property, or any interest and rights therein legal or equitable or otherwise howsoever.

To take, hold, own, maintain, work, develop, sell, lease, exchange, build upon, improve or otherwise deal in and dispose of such real estate and real property or any interest therein, to deal with any portion of the lands and property so acquired, subdividing the same into building lots, and generally laying the same out into lots, street and building sites for residential purposes or otherwise, and with power to construct streets thereon, necessary sewerage and draining system, and to build upon same for residential purposes or otherwise.

To act as general agents for employment, and also for the sale and purchase of real estate and all interests therein, and for reward to procure real estate investments for any person.

To act as managing and or selling agents for the owners of any real estate, of any kind, or any interest therein, and to take over and acquire from any person or corporation any agency exclusive or otherwise for the sale of any lands, sites or interest therein.

Generally to act as real estate, house and rental agents, and as incidental thereto to carry on the business of insurance brokers and insurance agents.

To carry on business as financial and investment agents and either as principal or agent to buy, sell and deal in, stocks, bonds, debentures, mortgages on real estate and on personal property, securities, notes and obligations of all kinds, to collect and dispose of interest, dividends or income upon or from such stock, bonds, debentures, mortgages, securities, notes and other obligations.

To cause or allow the legal title, estate and interest in any property or business acquired, established or carried on by the Company to remain or to be vested or registered in the name of or carried on by any other company or companies, foreign or domestic, formed or to be formed, and other upon trust for, or as agents or nominees of this Company, or upon any other terms or conditions which may be for the benefit of this Company, and to manage the affairs or take over and carry on the business of such company or companies so formed, or to be

formed either by acquiring shares, stocks or other securities thereof, or otherwise howsoever, and to exercise all or any of the powers of holders of shares stocks or securities thereof and to receive and distribute the dividends and interest on such shares, stocks or securities.

To buy, sell and deal in or with, whether by wholesale or retail, oils, grease, gasoline, benzine, petroleum, derivatives of petroleum and all kinds of petroleum products and by-products thereof.

To purchase, lease or otherwise acquire, hold, own, maintain, manage and operate garages, gasoline oil and petrol-um products stations, storehouses, store-rooms, warehouses and other like places for the safe-keeping, cleaning, repairing and care generally of automobiles and motor cars of all and every kind and description and class, and of all accessories thereof and thereto of every and any kind and description.

To lease and hire motor cars, trucks and automobiles of all kinds, to carry and transport passengers and freight in same upon such terms and conditions as the Company may consider advisable, and to buy, sell, service and deal in automobiles, motor cars, motor cycles, auto trucks and all kinds of motor vehicles whether used for pleasure or commercial purposes and whether driven by gasoline or any substitute therefor or by electricity.

To take over, manage and dispose of in any manner whatsoever any business or undertaking in which the Company may be interested or in the securities of which it may have invested its funds or with which it may have business relations.

To promote, organize, develop, manage or assist in the promotion, organization, development and management of any corporation, company, syndicate, enterprise, or undertaking, and, as incidental thereto, to undertake, manage, control or otherwise deal with the business and undertaking of any corporation, firm or individual for the purpose of protecting securities issued thereby realizing upon the claims thereon or carrying out to completion any transaction thereof in has undertaken any obligation or responsibility.

To procure capital, credit or other assistance for establishing, extending or reorganizing any enterprise or industry carried on or intended to be carried on by any person, firm, corporation or company.

To issue paid-up shares, bonds, debenture stock and or other securities for the payment, either in whole or in part of the purchase price of any property real or personal, claims, privileges, licenses, concessions, franchises or other advantages which the Company may lawfully acquire and for carrying out or work performed for the Company, and also to issue such fully paid-up
