The Honourable The Attorney-General reports for the information of the Com-mittee of the Executive Council that he has received a recommendation signed by the Judges of the Supreme Court as follows

"To The Lieutenant-Governor and Members of the Executive Council

The Judges of the Supreme Court rec-ommend, under Section 71 of The Judi-cature Act (Cap. 113, The Revised cature Act (Cap. 113, The Revised Statutes 1927) to the Governor in Council that the said Act be amended by adding thereto the following section, to be Sec-fon 79 thereof: 79-(1). Where any cause or matter

has been partly heard before any Judge of the Supreme Court, in either the Chancery or King's Bench Divison, and such Judge dies or retires, or for any other reason becomes unable to finish the hearing thereof, the Chief Justice, on the application of either party, on notice of motion, may assign another notice of

Judge to re-hear the same. (2) Where any cause or matter has been fully heard before any Judge of the Supreme Court, in either the Chan-cery or King's Bench Division, and such Judge dies or retires, or for any other reason becomes unable to deliver judgment therein, the Chief Justice, on the application of either party, on notice of motion, may assign another Judge to rehear the same, or, with the consent of all parties interested, to decide the sume, after re-argument, on the evidence already taken.
